A RESOLUTION OF THE BOARD OF DIRECTORS OF THE VALLE AMBULANCE DISTRICT, MISSOURI, ADOPTING ORDINANCE 2015.01

WHEREAS, the Board of Directors of the Valle Ambulance District requested that the voters consider approving a sales tax on April 7, 2015; and,

WHEREAS, the required majority of the voters of the Valle Ambulance District voted in favor of the imposition of a sales tax on April 7, 2015; and,

WHEREAS, the result of the April 7, 2015 election has been certified by the election authority of Jefferson County; and,

WHEREAS, the Board of Directors of the Valle Ambulance District must adopt an ordinance authorizing the sales tax before such tax can be imposed.

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE VALLE AMBULANCE DISTRICT, MISSOURI, AS FOLLOWS:

SECTION 1. The Board of Directors hereby adopt Valle Ambulance District Ordinance 2015-01 imposing a One Half Cent Sales Tax to Implement the Will of the Voters Expressed on April 7, 2015.

<u>SECTION 3</u>. The Chairman of the Board of Valle Ambulance District shall have authority to sign the Ordinance and Order to impose the One Half Cent Sales Tax as set forth in Valle Ambulance District Ordinance 2015-01.

SECTION 4. This Resolution shall be in full force and effect upon its passage on April 22, 2015.

VALLE AMBULANCE DISTRICT ORDINANCE 2015-01

AN ORDINANCE OF THE VALLE AMBULANCE DISTRICT OF JEFFERSON COUNTY, MISSOURI, TO IMPOSE A ONE HALF CENT SALES TAX TO IMPLEMENT THE WILL OF THE VOTERS AS EXPRESSED ON APRIL 7, 2015 AND AS DULY CERTIFIED ON APRIL 9th, 2015 AND AS AUTHORIZED BY 321.552 RSMo THROUGH 321.554 RSMo

Section I. Recitals:

WHEREAS, the Board of Directors by Resolution voted to submit this sales tax initiative to the voters, and

WHEREAS, this legislation (321.552-321.554 RSMo) contained a sales tax with property tax rollbacks in subsequent years, and

WHEREAS, the District nonetheless reserves the right in subsequent years per 321.554 RSMo the to make adjustments in the property tax levy to compensate for more or less increases or decreases in sales tax revenue than those originally estimated and further reserves the right to reverse any voluntary property rollbacks per the authority contained in 190.043 RSMo, and

WHEREAS, the District filed its timely notice of the election as required by 115.125 RSMo and the Circuit Clerk was thereby directed to place said sales tax initiative on the ballot, and

WHEREAS, the voters adopted this ballot measure by majority vote on April 7, 2015 and the results of the election were certified on April 9th, 2015, and

WHEREAS, on April 22, 2015 the Board of Directors met and adopted by Resolution this Ordinance to Impose said one half cent sales tax to take effect as soon as practical in 2015.

II. ORDER

Be it so hereby ordered to impose the duly adopted one half cent sales tax District wide, which is a new sales tax, with said revenues to be used for ambulance district operations, and with this Ordinance to be perpetual unless repealed by the District at a later date, and to submit to the Department of Revenue the necessary documentation relating hereto.
